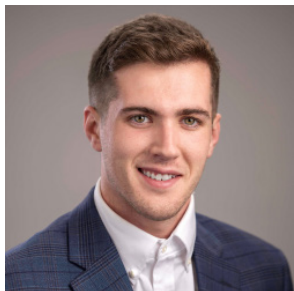


LINDSEY ADEN

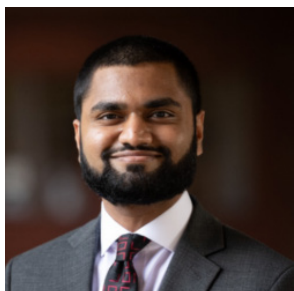


WYATT ANSEL

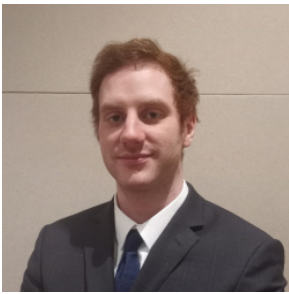


MARY LEE

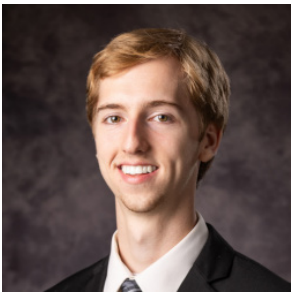


HANNAH STREITMAN
